#### 5. FIRE-FIGHTING MEASURES

##### Suitable extinguishing media:

Carbon dioxide (CO<sub>2</sub>). Dry chemical. Water spray mist or foam.

Thermal decomposition can lead to release of irritating gases and vapors. Keep product and empty container away from heat and sources of ignition. In the event of fire, cool tanks with water spray.
